1. GENERAL PROVISIONS

- 1.1. This Privacy Policy applies to a Website / Interface <https://jetton-demo.asterizm.io/> and to all Services available on the Website. If you do not agree with provisions of this Privacy Policy, you have to restrain from using of the Website or any of other services offered on the Website. By visiting of the Website and by using service you provide us with an informed consent to process and use your Personal Data as specified in this Privacy Policy.
- 1.2. Legal grounds for processing:
 - 1.2.1. Existence of a contract between the user and us;
 - 1.2.2. Legitimate interest;
 - 1.2.3. Legislative requirements: Company may process User's Personal Data, if it is required by the law applicable;
 - 1.2.4. Consent.
- 1.3. We do not transfer your Personal Data to third parties, except circumstances mentioned in this Privacy Policy or Terms.
- 1.4. This Privacy Policy is subject to the JetTon Terms of Use available on the Website. Your use of the services is still subject to aforementioned Terms of Use.
- 1.5. We reserve the right to update this Privacy Policy from time to time. If the changes are significant, we may inform you about such changes by posting a notice on our Website. You can find the latest version of Privacy Policy on our Website at any time.
- 1.6. The definitions set forth herein and mentioned with capital letter, unless specifically introduced in this Privacy Policy, shall have the meaning as described in Terms of Use, which can be founded on the Website or, if the definition cannot be found in Terms of Use, shall have the meaning as is specified in the General Data Protection Regulation (Regulation (EU) 2016/679).

3. WHAT DATA WE COLLECT ABOUT YOU

3.1. «Personal Data» (also refereed as to the «PD», «Personal Information») shall mean any information, that identifies you. If you cannot be identified this Policy shall not apply.

3.2. As a general rule, Company does not collect your Personal Information and does not use any automatic tracking technologies. The Application leverages blockchain technologies that use only public information available on the blockchain. You are not required to provide any personal information to the Site. However, the transactions conducted from your wallets are publicly accessible on blockchain networks access through the Interface. Company does not track IP addresses, does not store Personal or message information or in any way use information to associate or cross-associate wallet data is not possible. Company will never collect your seed phrase or private keys. We will never ask you to share your wallet private keys or seed phrase. Never trust anyone or any site that asks you to enter your private keys or similar security information. Company may collect publicly available blockchain information relevant to your transactions for the purpose of utilizing such information in, or providing such information to third-parties building or maintaining, analytics pages and block explorers. Such information will always be anonymous and never tied to any personal information, and will only be maintained for as long as necessary for the stated purpose.

4. HOW WE USE YOUR PERSONAL DATA

4.1. We may deliver, personalize, and improve our Services by combining and using the information we have about you (including information we receive on and off our services) to understand how you use and interact with them. We also may use the information we have about You for the following purposes:

4.1.1. Provide, maintain, improve, and develop relevant features, content, and services;

4.1.2. Research and develop new services;

4.1.3. Detect and defend against fraudulent, abusive, or unlawful activity.

5. HOW WE SHARE YOUR PERSONAL DATA

5.1. Our Privacy Policy applies only to the services, that are offered on the Website. We do not exercise control over any website that may be linked to from within content on our Website. We are not responsible for the privacy practices or content of such websites.

5.2. We do not transfer Your Personal Data to third parties, except cases, that are mentioned in this Privacy Policy which are next:

5.2.1. With our partners.

5.2.2. To comply with the law.

5.2.3. In an emergency. We may share information if we believe it's necessary to prevent imminent and serious bodily harm to a person.

5.2.4. To enforce our policies and rights.

5.2.5. With our Affiliates.

5.2.6. With your consent.

5.3. Other information, that does not personally identify You as an individual is collected by Company (in case if it is collected) and is exclusively owned by us. We can use this information in such manner on our sole discretion, deems appropriate.

6. LENGTH OF DATA RETENTION

6.1. We retain your Personal Data to fulfill our legal, operational, contractual and regulatory obligations. For each type of records, the recordkeeping requirements may vary so we guarantee that in no event shall we retain your Personal Data longer than required.

7. SECURITY OF YOUR PERSONAL DATA

7.1. Company protects your Personal Data under internationally acknowledged standards, using physical, technical, and administrative security measures to reduce the risks of loss, misuse, unauthorized access, disclosure, and alteration.

7.2. The safety and security of your Personal Information also depends on you. Unauthorized entry or use, hardware or software failure, and other factors, may

compromise the security of PD at any time. Your wallet is protected by your password, private key, and/or seed phrase, and we urge you to take steps to keep this and other Personal Information safe by not disclosing your security credentials or leaving your wallet open in an unsecured manner. We seek to protect Personal Information by refraining from collecting Personal Information where possible. However, these measures do not guarantee that your Personal Information will not be accessed, disclosed, altered or destroyed by breach of such firewalls and secure server software. By using the Site, you acknowledge that you understand and agree to assume these risks.

8. KNOW YOUR RIGHTS

8.1. If you are a resident of the European Union, you have certain data protection rights under the GDPR:

8.1.1. request access and obtain a copy of your Personal Data;

8.1.2. request rectification or erasure of your Personal Data, (applies also to non-EU residents);

8.1.3. object to or restrict the processing of your Personal Data; and

10. NOTIFICATION

10.1. If Company becomes aware of security systems breach, then we will attempt to notify you electronically so that you can take appropriate protective steps. Company may post a notice on our Website if the security breach occurs.

10.2. In the event that company is acquired by or merged with a third-party entity, we reserve the right, in any of these circumstances, to transfer or assign the information we have collected from our Users as part of such merger, acquisition, sale, or other change of control. If we become involved in a merger, acquisition, or any form of sale of some or all of its assets, we will notify users before Personal Data is transferred and becomes subject to a different privacy policy.
